



Lighting Design Terms & Conditions

1 - General Terms

- 1.1 - The lighting design service provided by Philip Payne is a non-contractual service.
- 1.2 Lighting designs are carried out in accordance with any information provided to us. Philip Payne will not be held responsible if inaccurate, incomplete or out of date information is provided.
- 1.3 Lighting designs will be carried out in accordance with CIBSE/SLL and British/Irish Standard guidelines unless advised otherwise.
- 1.4 Maintenance factors, working plane heights and room reflectances will be assumed to be in line with CIBSE/SLL, British/Irish Standard or CIE guidance unless advised otherwise.
- 1.5 All lighting designs assume a nominal site voltage of 240V.
- 1.6 For indoor applications, all lighting designs assume a nominal temperature of 25° C unless advised otherwise.
- 1.7 It is the responsibility of the client to check that the design meets the requirements of the project. Any inaccuracies should be brought to the attention of the Philip Payne Lighting Design department as soon as possible.

2 - Emergency Lighting

- 2.1 Philip Payne will have prejudged areas that are likely to require emergency lighting in compliance with BS 5266-1, -8 and BS EN 1838 but the scheme will be subject to an end user/employers risk assessment. Before any final emergency design can be signed off, it will be necessary to review the risk assessment, in addition to ensuring coverage of all 'points of emphasis' such as fire fighting equipment and fire alarm call points. Consequently, our design is limited pending this information and therefore may invalidate any building insurance.

3 - Schematic Drawings

- 3.1 Where schematic drawings have been provided in either AutoCAD or PDF format we will endeavour to ensure the scale of the drawings are correct in our designs. However it is the responsibility of the client to ensure that any scaling indicated in our designs/drawings are correct and any inaccuracies should be brought to the attention of the Lighting Design department.
